d) Other Planning Matters

218) Matters of Local Interest or Concern (by prior notice)

Recreation Ground - Friends of Bedwellty Park and members of the public were concerned regarding the potential leasing of the recreation ground through the Aneurin Leisure Trust, as to what type of lease would be allowed by the Local Authority and could the ground be bought in the future. Members were informed that the ground was currently still being run by the Grounds Maintenance Team of Blaenau Gwent CBC; however, the Local Authority Leader had announced that the Council would be looking at asset transfer by April 2019.

Councillors M. Cross, T. Smith and H. Trollope were working with the sporting community, and the Coalfields Regeneration Trust, as the Members had been invited to a meeting to seek the views of the public asking if anyone could facilitate, where it had been agreed to contact Coalfields Regeneration Trust. A working party had thereupon been set up with one person from each sporting organisation. A further meeting would take place following Trust representative, Alan Taylor, drawing up a constitution and terms of reference. Concerns were raised that after a certain number of years, sporting assets could be sold for housing development.

A Member said this ground had been donated by Lord Tredegar for recreational purposes on a one-hundred-year lease and, if the Local Authority disposed of the ground, it should be returned to the Estate.

Members confirmed that good practice elsewhere had been considered and adopted at the first meeting.

In response to an enquiry regarding the group to be established, it had been agreed by the working party that it be known as a Sporting Academy; which was welcomed by Members.

Metro for S.E. Wales – concerns had been raised previously by Council that Tredegar was not included; a Member had sight of the cycle network and unfortunately the situation was exactly the same; whereby Tredegar had again been omitted, which she deemed disappointing.

It was agreed that a letter be forwarded to the First Minister, expressing concern that Tredegar was missing from the network and asking that the transport priority mapping be reviewed immediately, with a copy to the local Assembly Member.

The Clerk suggested that Officers of BGCBC may also be able to advise on this issue and would liaise accordingly.

There being no other business, the meeting closed at 7.46 p.m.
