TREDEGAR TOWN COUNCIL

Minutes of the Ordinary Meeting of Council held in the Council Chamber, Bedwellty House on Wednesday, 17th April, 2019 at 6.00 p.m.

420) Apologies: Councillors D. Jones and S. Trollope

421) Declarations of Interest

The Chair reminded Members to make their declarations as and when necessary.

422) Invitation extended to Inspector Amanda Thomas and PS Neil Pigeon to discuss any issues of concern

PCSO Blunt was in attendance; the Officer expressed the apologies of Inspector Amanda Thomas, who had been called to a meeting, and PS Neil Pigeon. As the PCSO was the only Officer on duty within Tredegar at that time, it was agreed that she may leave, and any issues be referred to the Inspector accordingly.

Councillor S. Rees joined the meeting at this juncture (6.08 p.m.)

Members thereupon raised the following areas of concern:

Car parking in general

- Fountain Inn vehicle parked in bus stop at Troed y Gwair in early hours of the morning, resulting in ASB (playing music, drug use); update on what action being undertaken; Members considered this an important building
- Incidents over Bank Holiday general ASB, e.g. throwing eggs would have been helpful to be apprised of the proposed action programmed for the Bank Holiday weekend
- Stockton Way groups of youngsters intimidating, need police presence during summer months, effecting business, people scared to visit the town centre – intimidation, swearing, etc.
- Police had a duty to contact owner of the Punch House, although boarded up was broken into daily, located next to business establishments. There was obviously still a power supply, as there was a TV on site. The owner no longer lived in Tredegar and unfortunately appeared not to care of the ongoings. Members considered some form of action could be taken (e.g. Enforcement Officer / Environmental Health), and that a strongly worded letter was needed. Concerns were also raised in regard to the number of young people going back and fore the premises, some in school uniform.
- Traffic police needed in the armoury hill area, cars were racing at Thomas Ellis Way
- ASB in relation to mountain fires and motorbikes: a Members said there was no comprehensive policy to deal with such nuisance. Another Member said that whilst filming was being undertaken in Trefil approx. thirty / forty motorbikes were in the area and this had effected walkers, horses and small children. Members were concerned that such behaviour would deter people from visiting Trefil and was also causing damage

It was agreed that the Clerk write to Inspector Thomas in respect of the concerns raised.

423) To receive verbal recommendations of the Finance; i. Events; and, ii. Performance Review Sub-Committees held immediately prior to this meeting

The following were recommendations of Sub-Committees held 17th April, 2019, to be presented to Council for ratification and subsequent approval:

 - RFO to liaise with the recommended Company to offer the contract for design and print of The Bevan Festival brochures for 2019.
 - RFO to seek tenders for the provision of the Christmas Lighting provision for Tredegar town centre in accordance with previous provision and the amendments agreed.
 - Quotations be sought in respect of Insurance Renewal for a period of one, three and five years.
- Events Sub-Committee
 - No current recommendations, with actions ongoing.
- Performance Review Sub-Committee
 - Budget Against Actual figures to the 31st March, 2019: recommendations were noted and agreed accordingly
 - Revised Reserves, as at 31st March, 2019 were accepted accordingly
 - The Asset Register, as at 31st March, 2019, was approved accordingly

424) Accounts: to consider a Schedule of Accounts for payment in April 2019

The RFO spoke to the report and explained that the bank reconciliations were available for Members to view. Members thereupon raised the following points for consideration:

- Shopping Precinct it was noted that the water charges, rates, utilities, etc. could be substantially more than the grant awarded by Blaenau Gwent CBC. The new owners were looking forward to working with Council: it was therefore agreed that an invitation be extended to a future meeting to receive a presentation.
- Presentation Awards Evening Members welcomed the success of the recent event, acknowledging the opportunity to recognise such well-deserving members within the community, e.g. Tony Gregory Award.
- Public Conveniences Members raised a query in respect of the £10,000 allocated for public conveniences, (Ebbw Vale, Brynmawr and Tredegar), and asked for a breakdown from the Officer, querying if the remainder was allocated to Ebbw Vale (i.e. £6,000). A response had not been forthcoming and it was therefore agreed that the Clerk write to Matthew Perry for a meeting to discuss the grant available. A Member considered it inappropriate that Non-Domestic Rates of £1,400 was levied for the public toilets and considered the TTC should be exempt, particularly as Council was taking responsibility of a Local Authority service. Council was informed that only charitable companies were currently deemed exempt.

A Member said the criteria was needed in respect of how monies were allocated; the Chair said that allocation was based on monies received by Blaenau Gwent CBC through advertising boards.

Heritage Sub-Committee - 6th March, 2019

 Memorial plaque – Mining industry: met with Coalfields Regeneration to discuss gates, explained that TTC willing to support project of plaque, agreed proposal but would not run with gates, Mr. Sullivan insisted there was currently no memorial to miners in Tredegar. There was a meeting next Thursday, hopefully a further update could be given following that meeting.

Suggestion: stone-like memorial, school could be possible site for location or the Post Office, Commercial Street (the owner had indicated support and would allow any unveiling) of the stone and plaque. Concerns were raised if individuals were collecting

funds, official fund-raising would have to be properly constituted/structured. The Chair confirmed that it had been agreed in the meeting to set up a fully constituted group, with a designated bank account and proper officers, or via another constituted group, e.g. Business Forum.

- Bomber crash memorial: funding opportunities available through the Armed Forces Covenant Fund, however monies allocated had to be spent within a twelve month period. As the anniversary was next December, Council could continue with preparatory work.

Civic Meeting of Council - 6th March, 2019

- Dragon weathervane: image circulated to progress.
- Civic Awards presentation evening: Council extended thanks to House staff, the event had went well and the food excellent. It was a pleasure to recognise individuals of all ages both great and small.

A Member said he was disappointed with communication with the delegate of that Body, following the meeting with Architects, no further communication had been received since staff had left the Health Authority. Information had been circulated to residents' homes informing them of an event on 16th May, 2019.

4) Aneurin Bevan University Health Board In respect of Park Row Health Centre, residents in the vicinity had great concerns of the effect this would have on Market Street and how the continued use of Health Centre would fit together. However, residents welcomed the work being done and in respect of retaining features, but had concerns regarding access.

It was noted that a local pharmacy had invested monies in the regeneration works in Tredegar. Council was aware that the Health Board had invited eight local pharmacies to tender and Nelson Pharmacy had won the bid.

Agreed: Councillors M. Turner and J. Thomas to draft appropriate letter on behalf of Tredegar Town Council.

 - Noted. Mr. Jenkins was inaccurate in the content of his letter, as this was a lease and not an asset transfer. These organisations had not wanted to take on responsibility for sporting

grounds but had been forced to by Blaenau		
Gwent CBC. A Member considered the town		
would be far poorer for the loss of such facilities,		
and would not be opposed to the handover of		
the Bowls Club as he believed the Club would		
make good of this responsibility.		

A Member expressed concern in respect of some of the wording used as, although currently leased, could be sold in the future and that was also Mr. Jenkins' concern.

The Chair said the ground could not be sold and appropriate documentation was retained by Blaenau Gwent CBC. Also. sporting organisations had been informed by Blaenau Gwent that, as of 1st April, 2019, any sporting venues not considered under asset transfer would be closed. The Bowls Club had worked hard for that Pavilion, which he considered the best ground in S.E. Wales, and would not support going against that asset transfer, the majority of which were leased on a nil or peppercorn rent basis.

A Member commended the Club for taking on this asset and wished other clubs and organisations were as supportive.

Any concerns of Mr. Jenkins in respect of process should be referred back to Blaenau Gwent County Borough Council.
