160) Matters of Local Interest or Concern (by prior notice)

- 100th Birthday Council was informed of a 100th birthday of a Tredegar residential home resident in February; it was agreed that flowers be sent on behalf of the Mayor and Members of Council.
- Sincere condolences were extended to the family of Rowley Morgan, locally known as the Chair of the Medical Aid Society, on their loss; it was agreed that a letter be sent.
- Bevan Festival the WAWI committee, a group celebrating west Indians in this country, were fulfilling a significant role in the forthcoming NHS celebrations. A website had been established and asked that Tredegar Town Council submit items referring to the history of Wales / West Midlands as the birthplace of Aneurin Bevan and the cradle of the NHS. GAVO were on board, assisting in the development of a constitution and governance document. The proposed Hidden Hero Covid-19 Awards Ceremony in Tredegar, to be held the Monday following Bevan Day, with a VIP Royal guest to present was unlikely to proceed. The Group was exploring establishing an online event, as unfortunately they were not in a position to hold a big celebration.

 Hospital donations – a Member informed Council that the monies received by the Cefn Golau Tenants and Residents had been used to purchase toiletries for patients at Nevill Hall Hospital, Ysbyty Tri Chwm and Ysbyty Aneurin Bevan, who had offered their thanks for the support. It was the Member's intention to offer such support to the Grange also.

Another Member asked if it would be appropriate for Council to write to the A.M. and M.P. seeking support and outlining any concerns. Following a brief discussion, the Member was advised that any letter of political content should first be considered by Labour Group for appropriate discussions to take place.

It was therefore agreed that Tredegar Town Council award a grant of £250.00 to purchase toiletries for patients; Clerk to liaise with appropriate Member accordingly.
