077) Updates regarding Bedwellty House and Park / Parc Bryn Bach - any issues to have been previously reported direct to the House Management / Aneurin Leisure personally

 Members commended the wonderful work being undertaken by the gardener, team and volunteers, who were doing an excellent job. Congratulations were also extended on the work to the playground and tennis courts; Council was pleased to see such improvements.

078) Delegates: to receive and consider reports from Delegates to Outside Bodies and the recommendations of Sub-Committees / Working Parties:

- a) Joint Committee of Local Councils Next meeting scheduled for September.
- **b) Gwent Valleys One Voice Wales** Unfortunately, the Leader had to submit his apologies for the meeting.
- c) One Voice Wales Larger Councils and AGM No meeting.
- **d)** Tredegar Twinning The Association had been successful in their fund-raising at both Armed Forces Day and Aneurin Bevan Day and were very happy with the proceeds, and thanks were extended to a number of young and enthusiastic members, reinvigorating Twinning.
- e) Pen Bryn Oer Community Fund The fund was currently open to applications and the next meeting would be held in October.

f) School Governing Bodies – Bryn Bach Primary: appointed two new teachers, one full-time and one for a temporary contract, one teacher had been seconded to Blaenau Gwent CBC, only four teaching assistants had been appointed due to the economic situation. In respect of the resignation of the Town Council appointed Governor, this needed to be progressed through Council in order to nominate a representative.

Deighton Primary: two new teachers had been appointed and no less than six could have been shortlisted due to the high standard of applicants – one had joined the teaching system, following the closure of the Steelworks and completing training, and it had been a privilege to offer the applicant the post as a qualified teacher.

Georgetown Primary: Governor showcases were looking at various areas of the learning experience – the Member had attended two of the five sessions and the standard of work had proven excellent.

- **g)** Blaenau Gwent Heritage Forum Lectures undertaken on a Thursday as part of the Day School would be returning to Bedwellty House in October, following two years in Ebbw Vale and two years prior in Abertillery.
- h) Tredegar Business Forum Looking at the marketing strategy for buildings in Tredegar, there had been a poor uptake for grant funding. Planned events in the area related to 'Dinosaurs' and 'Princess' with a third event anticipated in addition to events to be undertaken for Halloween and Christmas. The Forum was looking for new members, as attendance of existing members had fallen.

079) Matters of Local Interest or Concern (by prior notice)

- It was agreed that a meeting be convened of the Tredegar Public Facilities Sub-Committee to discuss various matters in relation to the allotments in the remit of Town Council.
- A Member advised of a potential dangerous obstruction to the footpath in the vicinity of The Railway Tavern due to overgrown bushes obstructing access.
- A number of Members had attended the performance of Les Misérables at Tredegar Comprehensive School and highly recommended for those interested to attend if the opportunity arose, as this had been excellent production.
- Summer Bandstand Concerts concerns were again raised of the same Members supporting the band concerts; it was acknowledged that Members had their own individual commitments but the same few Members appeared to be giving their time to steward these concerts.
- Blaenau Gwent Gateway Features work was being undertaken throughout Blaenau Gwent in respect of Gateway features. Council was concerned that the wall to the roundabout at the one entry into Tredegar had been demolished a number of the years ago and had not been reinstated, despite repeated requests by Council. Also, as the Gateway from the A465, Members again highlighted the appalling appearance of the garage to this access point for Tredegar. A Member queried why the responsibility for the damage to the feature wall at the roundabout, as the result of a vehicular accident, had not been met by the insurance company of the motorist involved.
