DECLARATION:

Sections of the Local Government Act 1894 make it unlawful for local councils to award financial assistance *to projects which involve undertaking works of maintenance or improvement to property relating to the affairs of the church or held for an ecclesiastical charity*. Over more recent years, town councils have sought further clarification on these sections and whether they may have become out-dated and overtaken by later Acts of Parliament. Unfortunately and despite the efforts of local councils, it remains to be confirmed that the original legislation has been overridden and in the continuing absence of any relevant case law, further clarification seems unlikely at the present time.

Under these circumstances, the Town Council is asking all applicants to declare the following information:

1. That the award will be used to assist one or more community groups with the provision of activities that are of a non-religious nature, and
